

# **PRESS RELEASE**

March 18, 2020

In response to the COVID-19 situation and recommendations from Federal, State and Local Officials, effective March 19, 2020, Livingston County will reduce services and staffing to accommodate essential duties and services only. County buildings will remain open at this time. Hours and services may be limited based on the department. Staffing levels will be reduced to essential personnel only. Please refer to list below for guidelines. All employees and members of the public are encouraged to practice social distancing, maintaining at least a six-foot distance between people.

We understand that these reductions are unprecedented, but we feel this is the best way to keep the public and our employees safe during these difficult times. We will continue to reassess this evolving situation daily, and will provide updates to the community.

#### Assessor – (815)844-7214

The Livingston County Assessment Office will remain open with a limited staff. However, for the sake of everyone's health, we recommend contacting our office by phone or email as opposed to coming in person. Please refrain from coming into the office if assistance can be given in one of those two forms. All exemption deadlines will be extended to July 1, 2020. ### Circuit Clerk - (815)844-2602
