*Multi-State Information Sharing & Analysis Center* provides key resource for cyber threat prevention, protection, response & recovery for county governments.

#### Leadership/Learning Experiences

*NACo High Performance Leadership Academy* (12 week-online program).

*Legislative Conference & Annual Conference* provides education & networking opportunities.

*County News* is a NACo publication providing updates from Washington, DC and counties across the nation.

*County Explorer* provides research & data to help counties with grant proposals, county comparison statistics and county planning.

#### Civic Education

*U.S. Flag Retirement Program* allows counties to partner with local groups to collect and respectfully dispose of U.S. flags ready for retirement. NACo is currently partnering with UCCI to distribute one free flag retirement box to all UCCI member counties.

*The Stepping Up Initiative* is a national initiative to reduce the number of people with mental illnesses in jails.
